

Christian County Agricultural Fair

For the past 93 years, the Christian County Agricultural Fair has promoted agriculture and youth involvement in agriculture in and around Christian County. As the Illinois funding structure has changed, county fairs will soon have to be completely self-funded. In an effort to meet this challenge, the Christian County Fair is excited to announce its **1st Annual 60 guns in 60 Days Raffle**. We will be giving away 60 guns in 60 days beginning September 1, 2016 and ending October 30, 2016. We will be using the pick three system for selecting our winners, using the evening pick three from the Illinois State Lottery. **Locked and Loaded**, in Pana, Illinois will be our selected firearms dealer. Locked and Loaded is open 6 days a week, with a fully stocked gun inventory, on site shooting range, and accessories.

We will be selling 1000 tickets for \$100 each, starting May 1, 2016. Tickets are available from Fair Board Directors, Locked and Loaded in Pana, and by filling out the online form at www.christiancountyfair.com. Tickets will also be available through the fair office before and during the Christian County Fair. All forms must be signed and accompanied by \$100 payment.

- The raffle will begin Thursday September 1, 2016. Only 1,000 tickets will be sold.
- Raffle participants must be 21 years of age or older to purchase a ticket and I am at least 21.
- Winning ticket numbers will be determined by the Illinois Lottery "Pick 3" drawing every evening, excluding Fireball number, through October 30,2016.
- Every ticket sold will be eligible to win each day of the drawing.
- Each raffle winner is responsible for obtaining all required permits, licensing, training or other requirements required to purchase/own a firearm. (must have a valid FOID card in Illinois)
- All NFA rules/Laws apply
- Any extra charges (ex. Shipping, out of state transfer fees, etc) will be the responsibility of each winner.
- All tickets are non-refundable and non-transferable.
- 3 attempts will be made to contact each winner, at which time the prize will be forfeited. All prizes forfeited will become the property of the Christian County Agricultural Fair.
- Each Participant is responsible for notifying The Christian County Fair of any changes to their contact information.
- If 500 tickets are not sold a single winner will be determined by a 50/50 drawing, date TBA.
- All guns are purchased through Locked and Loaded. The Christian County Fair reserves the right to make substitutions of equal or greater value if the designated gun is not available for whatever reason.
- I am not under indictment, or any other crime, where the judge could imprison me for more than one year, or subject to an order of protection or any other court order that prohibits me from possessing a firearm. There are not state or federal laws prohibiting me from possessing or owning a firearm.
- I understand that if during the course of the raffle, I become ineligible to possess a firearm, the prize will be forfeited and my payment will not be refunded.
- I agree not to hold the Christian County Fair, any of their members, Locked and Loaded, any of its employees, or any other individuals involved in the raffle liable for any other reason related to the raffle.
- This raffle is void where prohibited.
